

## Ts&Cs of incentive „Server Revolutions”



The present Regulations use following definition:

**Organizer** – the PP1 Sp. z o.o. (Ltd.) with its registered office in Poland, Warsaw (02-916) at 31 Muszyńska Str., enrolled into the Register of Entrepreneurs kept by the District Court for the Capital City of Warsaw in Warsaw, 13th Commercial Department of the National Court Register, under KRS number 0000501997, NIP: 521-366-79-95, REGON: 147146920, represented by the general partner - the company PP1 Sp. z o.o. (Ltd.) on behalf of whom acts Paweł Jerzy Rzepecki - President of the Board,

**Distributors** - entities cooperating with Lenovo, which are authorized distributors of Lenovo products

**Lenovo** - Lenovo Global Technology Poland Sp. z o.o. (Ltd.) with its registered office in Poland, Warsaw (02-460), 1st G. Daimler Str., NIP: 522-307-57-99

**Partner** - an entrepreneur who is a Lenovo business partner who, as part of his business, purchases and sells Lenovo brand products.

**Portal** – Promotion / incentive website: <https://lenovosee-dcg.com/>

**Countries taking part in promotional campaign:** Greece, Cyprus, Hungary, Romania, Serbia, Slovenia, Bulgaria, Croatia, Montenegro, Macedonia, Albania, Bosnia and Herzegovina.

**Promotion** – promotional campaign „Server Revolution” taking place according to the present Regulations.

**Participant** - a natural person being the representative of the Partner, who on his behalf placed the order referred to in the Regulations, and then reported the Partner's participation in the Promotion.

## **I. General conditions**

1. The promotional campaign organizer is the Organizer. The Organizer works on behalf of Lenovo.
2. The aim of the Promotion is to increase the sales of Lenovo products purchased in the Authorized Distribution.
3. The promotion is aimed only at the Lenovo Business Partners.
4. Promotion applies only to orders placed from 1/08/2020 to 30/09/2020.
5. Transactions can be registered in promotion until 11<sup>th</sup> October 2020.

## **II. The Rules of the Promotion**

1. Products: Promotion concerns all Lenovo ThinkSystem servers with Intel® Xeon® Processors and attached options.
2. Promotion timeframe: 1st August - 30th September 2020
3. Concerns only bids done in Lenovo Bid Portal (LBP). Special grids excluded.
4. To participate in promotion participants must submit transaction in registration form and attach invoice from distributor.
5. Awards: prepaid MasterCards
6. Participant may represent only one Business Partner.
7. Participant may receive many prizes. There is no limit per person.
8. The Participant is required to have the appropriate consent of the Partner / employer to place the order referred to above and to submit the application in the Promotion.
9. The number of prizes is limited. The order of applications decides.
10. The order of entries is determined by the date and time of entry in accordance with the Regulations recorded in the Organiser's IT system.
11. After submitting the application and positive verification, partner can receive as an award:
  - ✓ 100€ on prepaid MasterCard for registration of transaction at the value between 5 000 - 10 000 EUR net
  - ✓ 200€ on prepaid MasterCard for registration of transaction at the value above 10 000 EUR net

### III. Awards

1. Material prizes for meeting the conditions of the Promotion are:

- ✓ prepaid MasterCard payment cards

2. The Participant is not entitled to claim payment of the monetary equivalent of the Prize or to exchange the Prize for another.

### IV. Taxation Rules

The Prize Winner is obliged to count the value of the Prize as his own revenues from business activity and to pay tax according to the binding tax scale. The organizer is not responsible for the consequences of failure to comply with tax obligations by the participant.

### V. Complaints and awards

1. Not later than 21 days after the end of the Promotion, the Organizer will send the Partner by e-mail (on the address provided by the Participant at registration) information about winning the Promotion, date and method of presenting the Prize.

2. Before issuing the Prize, the Participant on behalf of the Partner is required to complete, sign and return to the Organizer via e-mail a declaration of acceptance of the Prize. Failure to return a properly completed statement within 14 days prevents the Award.

3. In the event of comments regarding the Promotion, each Participant, acting on behalf of a given Partner, has the right to lodge a complaint within 14 days from the end of the Promotion to the e-mail address: [akruszewski@lenovo.com](mailto:akruszewski@lenovo.com)

4. The complaint should contain the name and address of the Participant and Partner, as well as a description and indication of the reason for the complaint. Complaints are considered by the Organizer and Lenovo within 5 working days from the date of their delivery. Complaints will be considered on the basis of the Regulations.

### VI. Processing of personal data

1. The administrator of Participants' personal data is Lenovo. Processing of Participants' personal data (i.e. name, surname, address, email, workplace address, employer's company, transaction number, distributor name) will be entrusted by Lenovo to the Organizer, in order to organize and conduct the Promotion and award prizes on behalf of and for the benefit of Lenovo, as well as to collect Users' consents to process data on behalf of Lenovo and conduct marketing activities on behalf of and for Lenovo (to the extent that the User has consented to the processing of his personal data for marketing purposes and for marketing communication).

2. The processing of personal data will take place basing on the principles provided for in the Act of 29 August 1997 on the protection of personal data (i.e. Journal of Laws of 2016, item 922) and from 25 May 2018 on the principles set out in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (GDPR).

3. Providing personal data by the Participant is voluntary, but failure to do so will prevent submitting an application in the Promotion.
4. The User has the right to access data and request to correct it.

## **VII. Final Provisions**

1. The Organizer reserves the right to exclude from the Promotion of the Partner in case of the violation by the Participant or Partner of these Regulations (in particular in case of submitting a notification that is not in accordance with the Regulations). In such a case, the Promotion application will be cancelled without awarding the Prize.
2. For important reasons, the Organizer reserves the right to amend the provisions of these Regulations, in particular in the event of changes in legal regulations or other significant events affecting the organization of the Promotion, preventing or particularly impeding the Promotion in a proper manner, which will not affect the Participant's acquired rights. Amendments to the Regulations may not worsen the situation of Participants. These changes are effective from the date of their announcement. 3. The organizer is the issuer of Promotional Awards and promising Awards within the meaning of Art. 919 of the Civil Code.
4. The Promotion Rules are only specified in these Regulations. All promotional and advertising materials are informative.
5. The organizer is not responsible for delays or any obstacles in communication with participants due to reasons beyond his control.
6. The promotion is not a game of chance, raffle, mutual bet or promotional lottery, the result of which depends on the case within the meaning of Art. 2 of the Act of 19 November 2009 on gambling (Journal of Laws No. 201, item 1540).
